Introduction

EDGA is committed to protecting your privacy and processing your personal data in accordance with the Wet Bescherming Persoonsgegevens (Dutch Data Protection Act). This policy explains how information we collect about you is used and kept secure, your privacy choices when using our website, and your right to access your information under the Dutch Data Protection Act.

The information we collect about you

Through the medical evaluation form applying for an EDGA medical pass and the mail@edgagolf.com email address, we may collect the following information about you: - Your name, email address, postal address and any other information you provide to us through the medical evaluation form or otherwise related to apply for a EDGA medical pass.

How we use your information

1. We only use your personal information to deal with your application for an EDGA medical pass. This information is dealt with by members of the EDGA Medical Committee only. The medical evaluation form is filed with the Chairman of the EDGA Medical Committee, to deal with other requests and enquiries we may have to;
2. Contact you for reasons related to your enquiry;
3. Notify you about updates to the www.edgagolf.com;
4. Use your IP address to monitor traffic and gather browsing behaviours of visitors to our website. We will not use your IP address to identify you in anyway;

5. To create meaningful, actionable analysis that will help the EDGA Executive Committee to understand how policy issues are being talked about and to react accordingly.

Your personal and medical information will be put on the EDGA Players List of pass holders which are only visible for members of the EDGA Medical Committee through a separate website. Medical Committee members hold an individual username and pass word to get access to this separate website. Your personal and medical information mentioned on the evaluation form is also the basis in case of a review of your eligibility to play EDGA tournaments and championships.

Your personal and medical information will not be used for marketing purposes or any other services unless you have specifically agreed to be contacted for these purposes.

Protecting your information

1. EDGA has appropriate technical and organisational measures in place to prevent the loss, misuse or alteration of your personal information.
2. Any personal information you provide to us is stored securely on password and firewall protected servers.
3. However, the internet is not generally a secure medium for communication and therefore we cannot guarantee the security of any information you send to us over the internet.

Portrait rights

EDGA may use “a portrait”, unless the person of (in) the portrait (or the maker/ photographer) has “a reasonable interest” to prevent the use of the portrait.

In such a case and if the EDGA Secretary is informed by email, EDGA will remove such portraits without undue delay.

EDGA will secure the relevant permissions to use photographs from the maker of the picture.

YouTube cookies

We embed videos from the YouTube channel, therefore, due to YouTube’s privacy-enhanced policy you may find that cookies are set on your computer once you have clicked to play the videos. However, YouTube does not store personally-identifiable cookie information relating to playbacks of embedded videos when using their privacy-enhanced mode. You can find out more at “ YouTube Help”.
